

DEFINITION


"Violence against women" means any act of gender-based violence that results in, or is likely to result in, physical, sexual or psychological harm or suffering to women, including threats of such acts, coercion or arbitrary deprivation of liberty, whether occurring in public or in private life." 1


CONTEXT

Violence against women (VAW) in its many pervasive forms is a global phenomenon that has been well documented. In Pakistan, too there has been an increasing spotlight on incidents of violence against women. Pakistan Demographic Health Survey 2012-13 reports that one in three women were likely to have experienced spousal violence in their lifetime.




% OF EVER MARRIED WOMEN (AGES 15-49) EXPERIENCED VIOLENCE

Cyber Bullying

- Pakistan's first Cyber Harassment Helpline became operational in December 2016.
- 736 complaints were received till May 2017.
- Female to male gender ratio in this case is 67:33
- It is reported that while 79% of women in Pakistan have regular access to the Internet, only 28% know about the laws that exist to protect them against cyber-bullies.
- 70% women will choose not to upload photos of themselves online in order to avoid harassment, 40% have received abusive messages online at some point.
- Regardless of this, 70% of women have never reported online harassment and 11% believe reporting cyber harassment would not be helpful.
